STANDARD MEASURES AND CORRESPONDING REBATES

LIGHTING

Retrofit lighting and controls **MUST BE PREAPPROVED**.

Interior LED Lighting	\$0.30 per reduced watt (W) OR \$300 per reduced kilowatt (kW)
Exterior LED Lighting	\$200 per reduced kW

Interior Occupancy Control	\$0.105 per W controlled
Interior Daylighting Control	\$0.015–\$0.12 per W controlled
Interior Advanced Daylighting Control	\$0.05–\$0.17 per W controlled

COMPRESSED AIR EQUIPMENT

VFD-controlled compressors	\$90 per horsepower (hp), under 75 hp
Receiver capacity addition	\$1.50 per gallon
Zero-loss condensate drains	\$90 per unit

Refrigeration condenser and evaporator fan VFDs	\$75 per hp
Floating head pressure controls	\$20 per ton of compressor capacity

HOW TO PARTICIPATE

LIGHTING RETROFITS

1. Complete and submit the retrofit lighting workbook application. Reserves rebate for **90 days**. Processed in **14 days** upon receipt of complete application.
2. Before ordering, purchasing or installing equipment, receive **written preapproval** from SRP.
3. Purchase and install the eligible measure(s) **after** approval.
4. Resubmit the workbook and dated invoice(s) for final approval.
5. Receive rebate within **4–6 weeks** of final approval.

LIGHTING NEW CONSTRUCTION AND NON-LIGHTING MEASURES

1. Complete and submit a rebate reservation request (optional). Reserves rebate for **90 days**. Processed in **7 days**.
2. Purchase and install the eligible measure(s).
3. Complete a rebate application or new construction lighting workbook. Processed in **14 days** upon receipt of complete application.
4. Receive rebate within **4–6 weeks** of final approval.

Rebate funds are limited and available on a first-come, first-served basis. Check the availability of program funds on the website or contact the program administrator at **(602) 236-3054**.

PLEASE NOTE: Customer will have 14 days to respond to SRP's request for clarification or additional information.
